Dear Regional Director Souza and Mr. Schoneman,

We're writing to you regarding the Fish and Wildlife Service's (FWS) role as a partner in the construction of the Red Hill Bay Project at the Salton Sea. The Red Hill Bay Project (RHB Project) broke ground in 2015 but has yet to be completed. Recent public reporting has indicated that the project is stalled and that both the Imperial Irrigation District (IID) and the FWS have outstanding obligations for this project.

For decades, inflows to the Salton Sea have been reduced, resulting in thousands of acres of exposed lakebed and rapidly declining water quality that threatens the local ecosystem and public health of surrounding communities. The RHB Project is a joint effort between IID and the FWS located on land owned by IID at the southern end of the lake. This project was designed to create over 600 acres of shallow saline ponds by mixing water from the Salton Sea and the Alamo River.¹ These ponds would facilitate new habitat for birds, while also preventing dust from emerging into the air.

The initial RHB Project Cooperative Agreement was signed in 2010, and construction formally began in 2016. The project was designed to be "the first decisive step in the efforts to restore the Salton Sea" and serve as a model for how landowners, project developers, and government agencies could work together to protect the public's health.² In June 2020, the Imperial County Air Pollution Control District (ICAPCD) issued air quality Notices of Violation to both IID and the FWS stemming from the incomplete project.

In order to identify the ongoing challenges and establish a path to forward to complete the Red Hill Bay Project, please return written answers to the following questions to our offices by June 17th, 2021.



- 6) What actions have the FWS taken with respect to the ICAPCD's Notices of Violation issued on June 22, 2020?
- 7) Please describe what steps FWS needs to take to complete the Red Hill Bay Project and FWS's plan to do so.

- 8) Does IID intend to re-purpose any land that is currently part of the RHB Project for geothermal energy and/or mineral development?


