Expressing the sense of Congress regarding the provision of a basic standard of humanitarian care to all individuals in U.S. Customs and Border Protection custody.

Mr. RUIZ submitted the following concurrent resolution; which was referred to the Committee on _____

CONCURRENT RESOLUTION

Expressing the sense of Congress regarding the provision of a basic standard of humanitarian care to all individuals in U.S. Customs and Border Protection custody.

Whereas two children, Jakelin Caal Maquin and Felipe Alonzo Gomez, recently died while in the custody of the Federal Government;

Whereas the Declaration of Independence sets forth that all individuals in the United States are created equal, endowed with the inalienable rights of life, liberty, and pursuit of happiness;

Whereas the United States was founded as a nation of men and women seeking freedom, refuge, and prosperity for themselves and their descendants;

Whereas the United States recognizes the inherent human dignity of all individuals;

Whereas the core values held by the Department of Homeland Security and U.S. Customs and Border Protection include integrity, vigilance, and respect;

Whereas U.S. Customs and Border Protection acknowledged that U.S. Border Patrol stations were built over 30 years ago for single adult males, not the humanitarian needs of families, and need additional resources to provide medical care, mental health services, and humanitarian assistance;

Whereas lack of access to adequate medical screenings, emergency medical care, shelter, sanitation, water supply, and food poses serious risks to individual and public health;

Whereas the United States is one of the original signatories of the Universal Declaration of Human Rights in 1948, which states that “recognition of the inherent dignity and of the equal and inalienable rights of all members of the human family is the foundation of freedom, justice and peace in the world”;

Whereas the Universal Declaration of Human Rights states that, “Member States have pledged themselves to achieve, in cooperation with the United Nations, the promotion of universal respect for and observance of human rights and fundamental freedoms;”

Whereas the Universal Declaration of Human Rights says that everyone, without distinction of any kind, “has the right to a standard of living adequate for the health and

well-being of himself [or herself] and of his [or her] family, including food, clothing, housing and medical care”:
Now, therefore, be it

1 *Resolved by the House of Representatives (the Senate*
2 *concurring)*, That it is the sense of Congress that—

3 (1) the United States must provide a basic
4 standard of humanitarian care to all individuals in
5 its custody; and

6 (2) U.S. Customs and Border Protection (CBP)
7 should—

8 (A) provide a standardized, adequate
9 health assessment by a trained and certified
10 health professional for each individual in its
11 care;

12 (B) have the medical equipment necessary
13 to respond to medical emergencies quickly and
14 efficaciously, including equipment necessary to
15 treat children and the elderly;

16 (C) have sufficient capacity to transport
17 individuals in its custody to the appropriate
18 medical facility in a timely manner;

19 (D) provide for adequate water, nutrition,
20 hygiene, and sanitation needs of individuals in
21 temporary CBP custody, consistent with a life
22 of dignity;

1 (E) provide living accommodations for in-
2 dividuals in temporary CBP custody that en-
3 sure such facilities are humane and appropriate
4 for single adults, families, and unaccompanied
5 children, and should have contingency plans for
6 responding to surges in individuals crossing the
7 border; and
8 (F) provide appropriate training in human-
9 itarian care for Federal and contract personnel
10 who interact with individuals in CBP custody.
